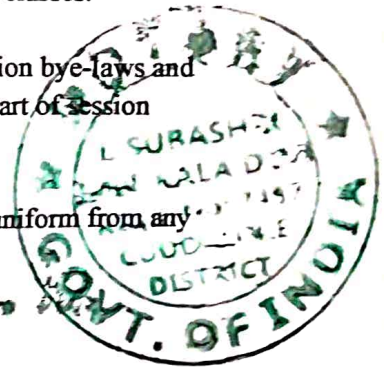

The school undertakes to abide by the provisions contained in the affiliation & examination byelaws directions issued from time and the law of the land.
